# BLO registers a new voter

ECI has brought in two new rules in this regard, madam. One can apply for voter registration as soon as they attain the age of 17 by filling Form 6 online via the NVSP portal or asking your BLO for the form. Once the applicant turns 18 years of age, they are automatically enrolled in the voter list.



Oh! We never knew about this new feature!

This means my brother can apply to become a voter right away?

Wow. But what about another rule Mr. BLO?

1st January, 1st April, 1st July, and 1st October of every year are the four qualifying dates for voter registration. This means if you are 18 years or above, you can register as a voter on any of the four qualifying dates in a year.

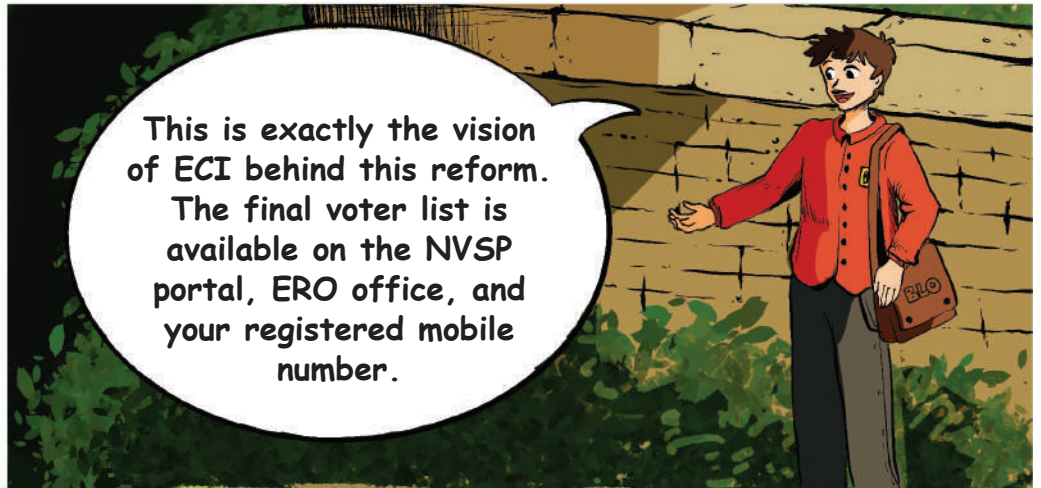

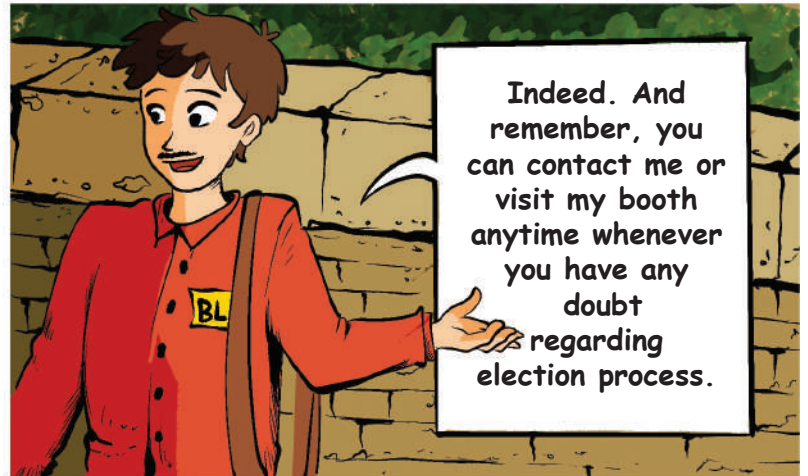
This means, we don't have to wait for an year to register!

Indeed. And remember, you can contact me or visit my booth anytime whenever you have any doubt regarding election process.



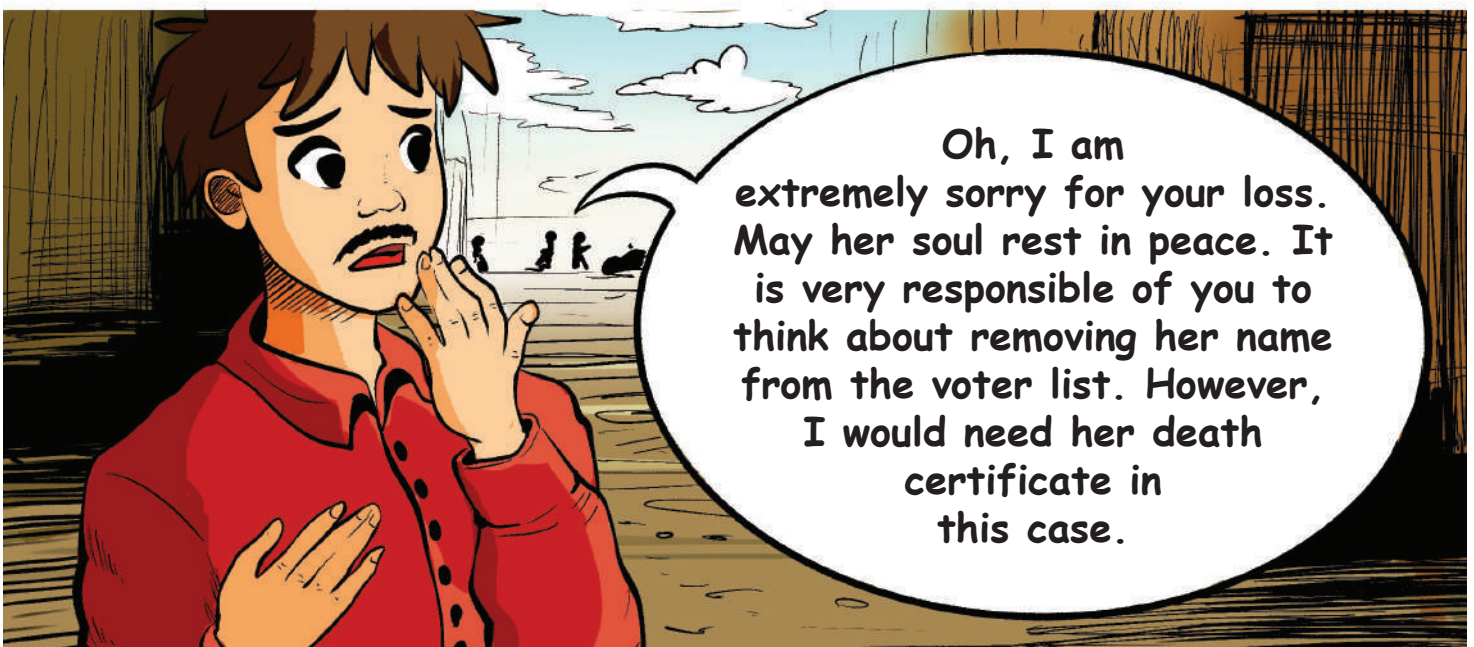
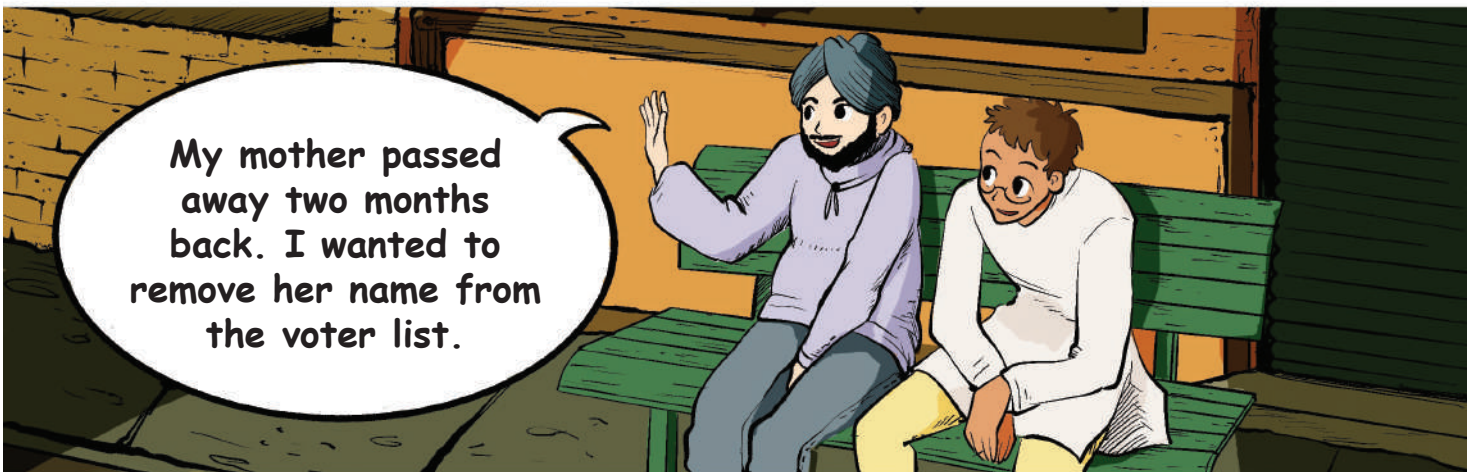
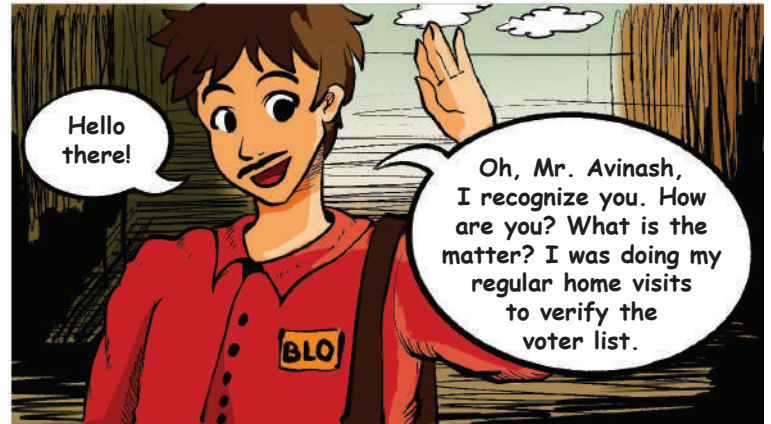

BLO walks to the next household in the street and catches 2 men sitting near the gates. One of them immediately recognizes the BLO and asks

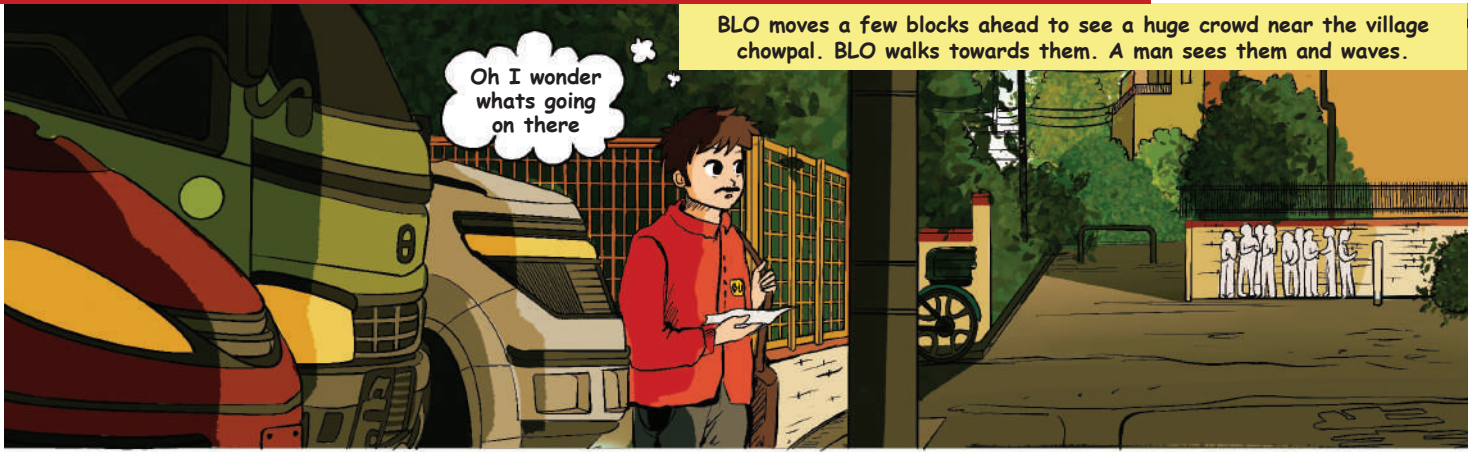




Avinesh fills out the forms and gives all the necessary documents to the BLO.



# BLO corrects name spelling & location in ER

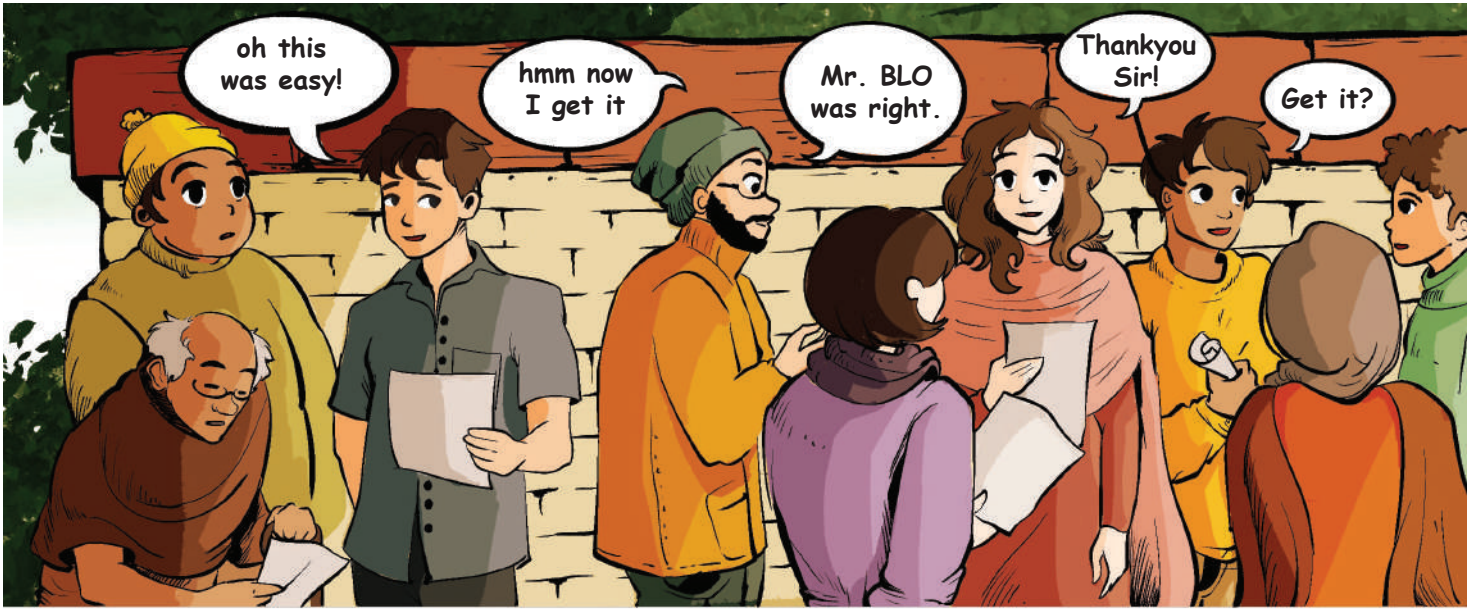

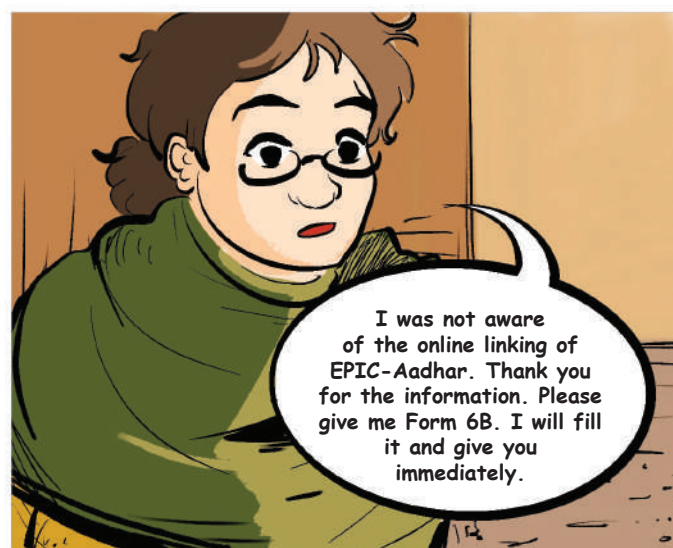
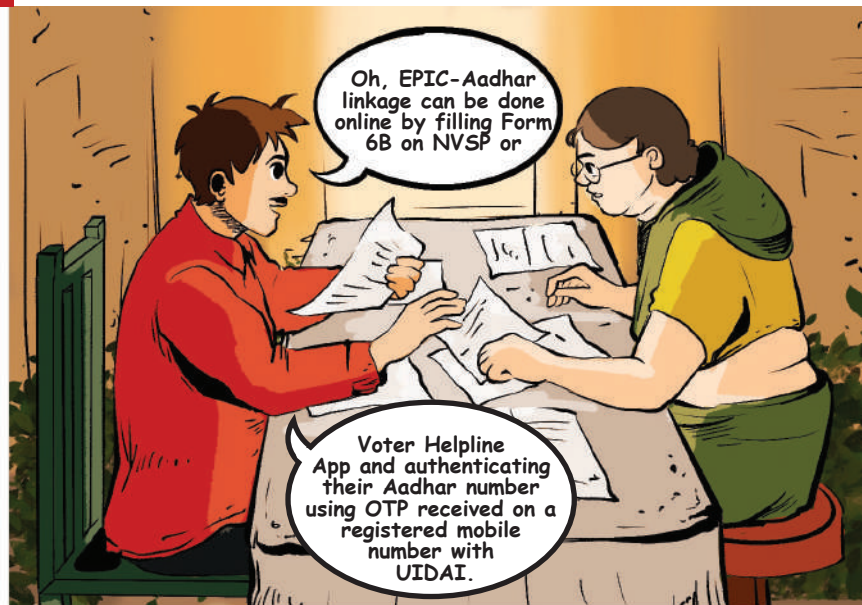


BLO reaches his polling booth after finishing his home visits for the day.
