We have audited the accompanying financial statements of **SWABHIMAN PARY**, (the "Party") which comprise the Balance Sheet as at 31st March, 2025 and the Income & Expenditure Account, Receipt & Payment Account for the year ended on that date, as well as the notes on accounts to the financial statements, including summary of significant accounting policies.

MANAGEMENT'S RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

The Political Party's Management is responsible for preparation and presentation of these standalone financial statements that give a true and fair view of the financial position and financial performance of the Political Party's in accordance with the accounting principles generally accepted in India including Accounting Standards prescribed by the ICAI. This responsibility also includes maintenance of adequate accounting records in accordance with the provision of the Representation of the People Act, 1951 for safeguarding the assets of the Party and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.



SCHEDULE-18

SIGNIFICANT ACCOUNTING POLICY AND NOTES ON ACCOUNTS:-

(1) Significant Accounting Policies:-

(i) Basis of Accounting:-

Financial statements are prepared under historical cost conversion on cash basis. Cash Accounting Method is used by the party as method of accounting since inception.

(ii) Going Concern:-

The Party's financial statements have been prepared using the going concern basis of accounting.

(iii) Fixed Assets:-

Fixed Assets are stated at their cost of acquisition less depreciation. Cost of acquisition of fixed assets including freight, duties, taxes and all incidental expenses relating to the acquisition.

(iv) Depreciation/Amortization:-

Depreciation is provided using Written Down Value Method, as per rate decided by management and has been provided consistently.

(2) Notes to Accounts:-

(a) Excess/Deficit of Income over Expenditure is before making provision for audit fees and Income tax.

(b) No donations are received from outside India.

(c) During the year it came to the notice of some of the office bearer(s)/member(s) of the Party that some of expel old office bearer(s)/member(s) have unblock/unfreeze the Punjab National Bank (Bhatapara Branch) bank account for which instruction was given in earlier year to bank official to blocked/freeze it. The expel office bearer have also collect fund in above said bank account. These expel official bearer/members are also making dispute that they are official bearer(s) of the party. However, transaction in the PNB (Bhatapara Branch) are not shown in the books of accounts or nor in audited financial statements.

In the earlier year, it was came to the notice of some of the official bearer(s)/member(s) the some of the expel official bearer(s)/member(s) who have misused the PAN card, Registration Certificate and other documents relating to the Party for Opening a Joint bank account in the Punjab National Bank (Bhatapara Branch) to collect fund and have withdrawn a good amount from the said bank without the knowledge of other Party member(s)/office bearer(s). In this regard, a Disciplinary Committee was formed by the Party and disciplinary action e.g. complaint/F.I.R. etc was taken against those expel office bearer(s)/ member(s) of the Party who were found indulged in such illegal activities/ anti party activities. Necessary action was taken by the office bearer(s) by informing the Election Commission in this regard. Therefore, transactions of earlier year in above said joint bank account made by such indulged office bearer(s)/member(s) were neither shown in the books of accounts nor in this audited financial statement of earlier year(s).

(d) Party has not received donations/contribution/subscription in excess of Rs 2,000/- (Rupees Two Thousand only) other than in account payee cheque or electronic mode.

(e) The Party has been provided with rent free accommodation or for a token rent by its members/ well-wishers for conducting its activities/meetings. Some volunteers/members have provided their vehicles for party use. The repair, maintenance and running expenses of these vehicles are borne by the Party.

(f) There are no contingent liabilities as on 31st March 2025 except a demand raised by income tax department of Rs. 95,400 (Rupees Ninety Five thousand Four Hundred Only) for AY 2018-19 and Rs. 3,77,590 (Rupees Three Lakh Seventy Seven Thousand Five Hundred Ninety Only) for AY 2019-20 against the Party.

(g) Previous year figures have been regrouped/re-classified, wherever necessary to make them comparable with the current figures.

(h) During the audit, it was informed us that Bank of Baroda account (Gaya Bihar Branch) was closed by the bank but trustee/management failed to provide sufficient documentation to verify the status and balance of the Bank of Baroda account. Hence, I/we are unable to verify the bank balance and status of bank account whether the account is actually closed or not.
